Staffing Functionality

Dashboard

Vacancies

Added a hover over tooltip to the *Vacancy Number*, which displays the PP-Series-Grade(s) and the Office for the Vacancy. Also, the PP-Series-Grade(s) hover over tooltip displays for the *Position Title*.

Vacancy

Added a *Linked Requests* page under Vacancy, which provides HR Users the option to quickly approve Additional Selection requests in Awaiting Approval status associated with that Vacancy.

Discontinued the automatic transfer of the *Candidate Inventory* tag from a Vacancy to a New Hire record, improving reporting accuracy on Candidate Inventory selections. **Note:** Users may still manually add the *Candidate Inventory* tag to a New Hire record created from a Certificate and the tag will continue to automatically transfer from Onboard New Hire Request types.

Announcement

Increased the character limit of the *Work Schedule* optional text field on the Announcement Text page to 250 characters in alignment with USAJOBS. **Note:** This field can be accessed by clicking the note/pencil edit icon under the *Work Schedule* field in the Overview section of the Announcement.

Added *History* entries when adding, editing, or deleting questionnaire items after the announcement is released and is in *Pending Open Date* status.

Added the ability for HR Users to add review *Followers* when creating, updating, or sending a Subject Matter Expert (SME) Review. HR Users can select followers from active Human Resources, Onboarding, or Hiring Manager Users as well as General Contacts.
